## Driving-Under-the-Influence (DUI) Medication Assisted Treatment (MAT) Integration/Outreach Pilot Project

# **DUI MAT**

The DUI MAT Integration/Outreach Pilot Project targets the development and implementation of a recognition and intervention pilot program for Opioid Use Disorder (OUD) and Polysubstance Use Disorder (SUD) to benefit DUI program participants.

DUI MAT services include education, pre-screens and 2nd level screenings, treatment referrals, and counseling support.

DUI MAT is a voluntary program and will not impact your DUI program or any legal proceedings.

#### **Benefits of MAT**

- → Reduce or eliminate withdrawal symptoms.
- → Reduce or eliminate cravings.
- → Block the effects of Opioids.
- → Stabilize brain chemistry that drives motivation and bonding with others.



#### What is Medication-Assisted Treatment?

MAT uses FDA approved medications with counseling to treat the whole person. MAT stabilizes the brain, controlling cravings and helping people to do the hard work of recovery. Without MAT, people with opioid use disorder (OUD) and Alcohol Use Disorder (AUD) are at a high risk of using again and possibly overdosing. MAT reduces the chance of relapse and supports long-term recovery.

### Is the DUI MAT Program Right for You?

DUI MAT is for anyone currently enrolled in a participating DUI Program who may have a substance abuse problem. While the project was developed to address the opioid crisis, you do not need to be exclusively dependent on opioids to participate in the DUI MAT program. Alcohol in combination with any other drug qualifies for DUI MAT.

The first step to determining eligibility is to complete the pre-screen provided to you by your DUI Program. If addiction is indicated, you will be referred to a 2nd level assessment at no charge to you. Upon completion of the 2nd level assessment you will meet with a counselor certified in Substance Use Disorder. The counselor will provide you with treatment referrals.

Once you are enrolled in DUI MAT, you will meet with the counselor on a regular basis as you complete your treatment program. You may continue receiving counseling services after your DUI Program has ended. DUI MAT will be available at select service locations through September 2020.
